Introduction: Diplomacy in the 21st Century

The purpose of the BMW Foundation Global Table in Poland is to provide an alternative space for building trust and focusing on the converging interests between Europe and Eurasia - at a time of growing divergence and uncertainty. The Global Table's mission is to introduce decision-makers to a diversity of voices and creative thought from all spheres, and to be able to translate new ideas on converging regional interests into formal diplomatic dialogues.

The agenda below outlines the process and the strategic questions that will be discussed in Poland. The meeting focuses on energy security, which represents a pivotal sector for Europe and Eurasia, for which cooperation and inter-dependence would be as advantageous, as growing fragmentation would be detrimental.

The challenges confronting diplomacy in the 21st century require a new culture of global partnership. In order to achieve this, new forums, like Global Tables, must respond to the need for bringing together a diverse and cross-sector group of leaders in informal settings, to nurture informal connections and ideas that may improve the formal positions of countries.

The results that develop out of this initiative will consist of a set of ideas and practical examples that participants will integrate into their work in formal diplomacy. Moreover, these insights will help guide the high-level discussions at the Berlin Global Forum in November 2015, which will further integrate Global Table participants and diplomatic agents to envision new alliances.
